Thanks in large part to the support of folks like you, Coalition for Kids had the opportunity this fall to expand our child care program by opening a new center on the Rogue Community College Redwood Campus. The new center is located in the same facility previously leased by the YMCA, which discontinued offering child care at RCC late last spring.

We started enrolling children at the beginning of October but

have been caring for them at our child care center in town while we've been getting the new center ready. Child care will begin on campus on January 3rd to coincide with RCC's Winter Term.

While priority will be given to RCC students and faculty, the center will be open to the entire community. We also offer wrap-around care for Head Start students who attend half-day classes at the Early Childhood Education Center, also located on

the Redwood Campus.

Graduate of Preschool Program Excels in Kindergarten

Parents Credit Child Care with Preparing Son for Success

How do you make sure your children have the best opportunities for success while ensuring they are healthy and safe if you work or go to school for most of the day? Money \$marts! Tips for Holiday Shopping

Thwarting Identity Theft

1. If you shop online and you have a choice between using your debit card or your credit card, use your credit card. If an identity thief nabs your credit card information, you’ll be out no more than \$50. If your debit card information gets stolen, your entire account can be siphoned off.
2. If your credit limit is high enough, put all online purchases on one card. Why? First, you limit an identity thief’s access to only one of your credit lines. Second, using one card makes it much easier to track how much you are spending.

FINANCIAL FACT: Twenty-five per cent of credit card debt incurred for holiday expenses still won’t be paid off twelve months later.
