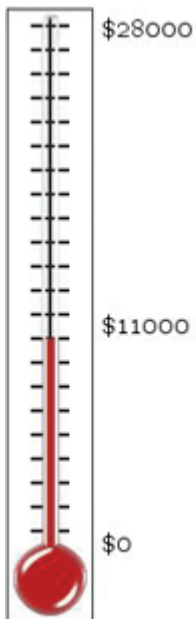

Hamilton House Annex In Escrow

It has been almost a year since the Board of Directors made the decision to list the current CFK property on the corner of 8th and M streets for sale. The Board had a vision of selling the property and building a new facility. No one expected to receive an offer on only a part of the property, so of course that is what happened. If all goes well the closing for the Hamilton House property will be May 15, 2007.

What will CFK do now?

The Board of Directors has met twice since the signing of the sale agreement to discuss just that question. Several decisions have been made. The first was to not continue listing the Family Resource Center for sale. The decision was also made to hold a strategic planning retreat, probably in late September or early October. The retreat will include input from FRC Partners, community partners and a Board process that will determine the actions CFK will take for the next 3-5 years.

The Board and staff are looking forward to the next several months as the future unfolds, and we see our mission of “*Creating Opportunities for Children and Families*” expanding to benefit even more families in the community.

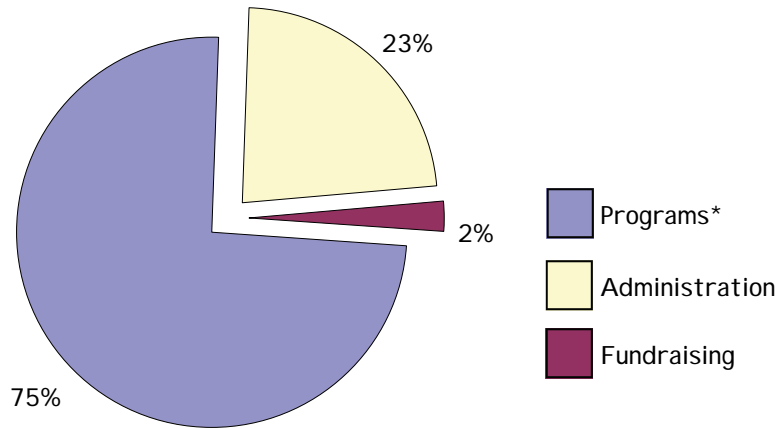

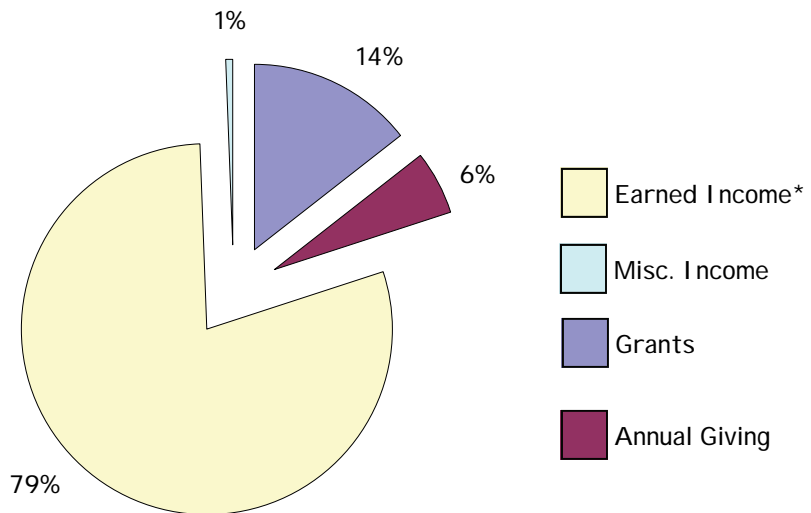
2005-2006 Breakdown of Expenses



*Programs include: Special Friends, Jobapalooza!, Family Connections, Love & Logic Parenting Classes and operation of the Family Resource Center.

According to the American Institute of Philanthropy's *Charity Rating Guide*, in most cases 60% or more of your charitable donation should go to program services. Less than 40% should be spent on general administration and fundraising costs. Coalition for Kids uses funds from grants and donations as efficiently as possible to provide a higher level of service to children and families in Josephine County.

*Earned income is from child care tuition and charges, rent, and parenting class fees.

Unlike the private sector where the price of a service is set to cover all costs, nonprofit agencies rarely meet all their costs based upon fees. Instead nonprofits must engage in fundraising and seek additional revenue sources.
